# America's Waterway Watch

- Post-9/11 to protect maritime interests
- Joint effort of USCG, Reserve & Auxiliary
- Increase awareness of maritime domain
- Partnered approach to alert public on suspicious behavior on the water/shoreline
- Report suspicious activity to NRC
- What is its objective?
  - Prevent infrastructure and the general public from being targeted

#### National Response Center Overview


- Receives reports of areas of concern
  - Environmental issues
  - Infrastructure security breaches
  - Suspicious activities
  - Terrorist-related events
- Notifies
  - Federal and State On-Scene Coordinators (OSC)
  - EPA and USCG Headquarters
- Preparedness role of NRC Support National Response System (NRS) planning





#### National Response Center Overview

- Report Suspicious Activity to call or contact:
  - National Response Center (NRC) at 877-24WATCH (877-249-2824)
  - Immediate danger to life or property, call 911
  - U.S. Coast Guard on Marine Channel 16 or via telephone.







#### National Response Center Overview

- According to 40 CFR 302.6:
- The Responsible Party (RP) must immediately notify the National Response Center (NRC) at 1-800-424-8802 or fax at 202-267-1322 as soon as one has knowledge of a CERCLA¹ hazardous substance release from a facility or vessel in a quantity that equals or exceeds the RQ."
- Contacting the local Coast Guard Command Center is sufficient enough to comply with 40 CFR 302.6



<sup>1</sup>CERCLA is the Comprehensive Environmental Response, Compensation, and Liability Act



#### What is the Critical Infrastructure?

- Defined as the physical and cyber systems and assets so vital to the US that their incapacitation or destruction would have a debilitating affect on:
  - Physical security
  - Economy
  - Public health and safety
- The critical infrastructure provides the essential services that underpin our society

#### What is the National Response System?

- Comprised of
  - Federal On-Scene Coordinators (OSC)
  - 13 Regional Response Teams (RRT)
  - National Response Team (NRT)
    - Provides technical assistance, resources and coordination
  - Area Committees
  - State and local Governments
  - Special Teams
  - Joint Response Teams with neighboring countries
  - Regulated Industry

#### America's Waterway Watch Is

#### > AWW is

- A public awareness program
- Leverages the boating community
- Like "neighborhood watch"
- Like WWII "Coastal Watch" Program
- A "see something, say something" campaign

#### > AWW is not

- Spying on our neighbors
- An intelligence gathering program
- Law enforcement investigation activity





#### What Do We Look For?

- Unusual operations of
  - Vessel or small boats
  - Vehicles on land in/around waterways
- Individual(s) activities
  - Taking still photos or videos of
    - Bridges, vehicles, facilities and other infrastructure
    - Government buildings
    - Government vessels or facilities
  - Other items that might cause harm





#### What Do We Look For (Cont.)?

- People running away from
  - Area(s) near a secure facility
  - Critical infrastructure (e.g. power plant)
- Engaged in what looks like surveillance
- Any conditions that look suspicious or don't look right
- What appears to be a physical breach of security





#### Again, What Do We Look For?

- Suspicious and unknown individuals
  - Loitering
  - Photographing, sketching or surveilling buildings, facilities, structures, etc.
  - Unusual activities (e.g. fishing and boating at odd times and/or places)
  - Clothing not appropriate
  - Asking inappropriate questions
  - Inquiring about security for public events
- Boats discharging persons or objects at unusual locations



#### What is Sea Partners?

- Environmental education and outreach program
- Develop community awareness of maritime pollution
- Improve compliance with marine environmental protection laws and regulations.





# What is Sea Partners Message?

- An understanding of the effects of pollutants in the marine environment
  - Oil
  - Hazardous chemicals
  - Waste and debris
- How marine environmental protection laws and regulations apply to marine users
- Ways groups and individuals can take action to protect the marine environment





#### Goals of Sea Partners

- Increase compliance with marine environmental protection (MEP) laws and regulations
- Educate waterways users on MEP laws and regulations
- Raise community awareness of marine pollution issues
- Prevent discharge of marine pollutants
- Increase citizen reporting of marine pollution issues





# Sea Partners Program Organization

- U.S. Coast Guard
  - Each Sector encouraged to have Sea Partners trained teams
  - Reserve members can receive orders to participate
- U.S. Coast Guard Auxiliary
  - Support Sector activities
  - Work through traditional Auxiliary outlets
    - Boating safety classes
    - Vessel safety checks
    - Marina visits
      - Boat show booths

# **AUXSCOUT Program**

- Boy Scouts program supported by USCG
- Authorized to use training and recreation facilities of USCG
- Participate in USCG operations
- 2009 Memorandum of Agreement (MOA) allows units to partner on projects (e.g. RBS)
- 2018 MOA revision created AUXSCOUT
- AUXSCOUT Standard Operating Procedures (SOP) to guide the conduct of the program





# AUXSCOUT MOA (2018)

#### Parties

- United States Coast Guard Auxiliary
- Boy Scouts of America
- Coast Guard Auxiliary Association, Inc.

#### Purpose

- Enhance common goals of promoting RBS
- Strengthen ties between the groups
- Afford Sea Scouts Auxiliary training opportunities
- Integrate vessels (units) into Auxiliary's programs
- Pathway for Sea Scouts to Auxiliary membership





# AUXSCOUT MOA (2018)

- Auxiliary Responsibilities
  - Conduct RBS projects with Sea Scouts
  - Shore-side and underway training
  - Safety checks on BSA/Sea Scouts vessels
  - Incorporate Sea Scout vessels on flotillas
  - Provide RBS and other literature
  - Designate a Point of Contact (POC) for MOA
  - Obtain and protect PII
  - Require youth protection training (< 18 years)</li>





#### **AUXSCOUT** Activities

- Operational activities/requirements
  - Vessel safety checks on BSA facilities
  - Auxiliary provide RBS and other literature
  - Auxiliary provide shore-side/underway training to Sea Scouts and other members of the BSA
  - Auxiliary ensure Sea Scouts/Leaders have personal protective equipment (PPE)
  - Auxiliary facilities with Sea Scouts aboard shall not be scheduled for SAR missions.
  - Ensure order issuing authority is aware facility will be carrying Sea Scouts/Leaders are on board

#### **AUXSCOUT** Activities

- Science, Technology, Engineering, Mathematics (STEM)
  - STEM activities authorized to be provided by Auxiliarists to Sea Scouts to supplement and <u>not</u> replace, Sea Scout rank requirements
  - STEM projects shall only be performed if they are aligned with Auxiliary training methods and materials.
