

#### **USCG** Marine Safety Prevention Missions strive to:

- Prevent marine casualties and property losses
- Minimize security risks
- Protect the marine environment

#### **USCG** does this by:

- Developing and enforcing federal regulations
- Conducting safety and security inspections
- Analyzing port security risk assessments



## The AUXILIARY Prevention Directorate serves two USCG missions:


- 1. Marine Safety/Environmental Protection (MS/MEP), comprised of four divisions:
  - Commercial Vessels
  - Port and Facility Activities
  - Prevention Outreach
  - Communication and Education



2. Navigation Systems (NS)

#### **Commercial Vessels Division**

- Led by the DVC-PV
- Responsible for Inspected and Uninspected commercial vessels:
  - Inspected Commercial Vessels include: Domestic vessels such as T-Boats and K-Boats
  - Uninspected Commercial Vessels include:
     Uninspected passenger vessels (UPVs)
     Uninspected towing vessels (UTVs)
     Commercial fishing vessels (CFVs)
- Auxiliarists can earn qualifications to assist in USCG missions; see Directorate website for training information



## **Port and Facility Activities Division**

- Led by the DVC-PS
- Responsible for:
  - Container Inspections
  - Marine Observation Missions (MOMs)
  - Regulated Facilities (e.g., warehouses, etc.)
  - Port State Inspections (Foreign flag vessels, including ocean-going cruise ships)
  - Waterways Management, including marine event planning and support

#### **Prevention Outreach Division**

- Led by the DVC-PW
- Responsible for programs affecting marine and freshwater environments:
  - America's Waterway Watch (AWW)
  - Sea Partners
  - Aquatic Nuisance Species
  - Living Marine Mammals Resources
  - Good Mate program
- Missions do not require formal qualifications; members with MS/MEP training (via courses found on the Directorate website) can support Outreach






#### **Communications and Education Division**



- Led by the DVC-PO
- Responsible for:
  - Design and maintenance of the Prevention Directorate website
  - Publication of the Directorate newsletter Safety Lines and other literature
  - Special projects /resources
  - Marine Safety Training programs
    - Marine Safety Training Ribbon (MSTR)
    - Marine Safety M-Pro Pin

## Marine Safety and Environmental Protection Chain of Leadership and Management (COLM)



#### **Marine Safety Staff Officer Attributes - All Levels**



- Lead by example
- Promote participation in MS/MEP activities in each unit
- Provide MS/MEP workshops and training opportunities
- Assist, support and proactively coordinate:
  - Augmentation for USCG MS/MEP missions
  - Environmental outreach, e.g., Sea Partners
  - Maritime security, e.g., America's Waterway Watch (AWW)

#### **Marine Safety Staff Officer Attributes - All Levels**



- Highly visible within their unit and beyond
- Understand the breadth of MS/MEP activities
- Build and maintain relationships:
  - Up/down the chain of leadership and management (COLM)
  - With other flotillas, divisions, and districts
  - With other staff officers, especially:
    - Public Affairs (PA)
    - Vessel Examination (VE)
    - Public Education (PE)
    - Program Visitors (PV)

#### **Tasks and Responsibilities**



- Maintain awareness for opportunities to promote MS/MEP
- Periodically establish / reestablish goals and objectives
- Maintain close liaisons with MS/MEP officers above AND below in the Chain of Leadership and Management (COLM)
- Identify best practices in their unit and share them proactively
- Submit regular and timely written reports to their unit and to staff officers upward in the COLM

#### **Auxiliary Volunteer Support and Outreach Efforts**

- Waterway cleanups
- America's Waterway Watch
  - Sea Partners
  - External organizations:
    - Riverkeepers
    - Local conservancy groups
      - Local civic organizations
        - Yacht clubs
  - Schools, colleges / universities

    - Special events

- Marine Safety Administration and Management Specialist (MSAM) PQS
- Prevention Outreach Specialist (MEES) PQS

#### Advanced level

- Marine Safety Training Ribbon (MSTR)
- Marine Safety M-Pro Pin





#### **Training and Qualifications - Basic**

- Introduction to Marine Safety and Environmental Protection (IMSEP)
  - Provides background in history, policies, laws and regulations of MS/MEP missions
  - Counts two points toward the Auxiliary Operational (AUXOP) award

#### Good Mate course

- Created by the Ocean Conservancy
- Auxiliary uses to teach clean boating and marinas

#### Incident Command System courses

- Offered online by Federal Emergency Management Agency (FEMA)
- Basic information about ICS purpose, structure, function, and use:

#### **Training and Qualifications - Intermediate**



- ICS 210 Initial Response Incident Commander
  - For members who may happen upon an incident requiring command direction until response personnel arrive; available online at USCG Auxiliary Classroom
- Marine Safety Administration and Management Specialist (MSAM) PQS
  - Prepares members to participate in MS/MEP programs and general missions
  - Recommended for MS/MEP Officers at all levels
- Auxiliary Prevention Outreach Specialist (MEES) PQS
  - Develops knowledge in environmental protection topics and programs; qualifies Auxiliarists to conduct relevant member training and public education
  - Auxiliary equivalent of the 12-week USCG Marine Science Technician A-School

#### **Training and Qualifications - Advanced**


#### **Marine Safety Training Ribbon (MSTR)**

- Recognizes dedicated training efforts and commitment to MS/MEP programs and missions
- Represents progress toward the Marine Safety M-Pro Pin
- Requirements for earning:
  - IMSEP course
  - Good Mate course
  - ICS 100, 200, 210, 700, and 800 FEMA courses
  - Completion of one MS/MEP qualification from list on the Prevention website

## Training and Qualifications - Advanced Marine Safety M-Pro Pin

- Recognizes completion of Auxiliary training and qualification in a Coast Guard needs-based program
- Program disciplines that Auxiliarists may pursue are aligned with needs of their respective Sector commands
- Symbolizes perseverance, excellence and professionalism in service to the USCG and the public
- Requirements for earning:
  - All requirements of the MSTR
  - Three additional MS/MEP qualifications from the list on the Prevention website, for a minimum total of four
  - Minimum of 96 hours of service per year for five years, as recorded in AUXDATA II in MS/MEP missions

   Conservation, Environmental Protection, or Fish and Game




#### National, District, Sector, Division and Flotilla Resources

- Both the Coast Guard and the Auxiliary seek to be more effective and efficient in meeting the needs of respective Areas of Responsibility (AORs)
- Divisions and flotillas may vary considerably among their individual MS/MEP initiatives and how associated assets are deployed
