Subj: AUXILIARY AVIATION PPE and DAY/NIGHT PYROTECHNIC FLARES UPDATE

- 1. <u>PURPOSE</u>. The purpose of this policy letter is to update Auxiliary aviation Personal Protective Equipment (PPE) policies in reference (a).
- 2. <u>ACTION</u>. All Auxiliary pilots, air crew members, and air observers must comply with the provisions in this Policy Letter. Elected and appointed leaders and program managers at all levels of the Auxiliary organization shall ensure adherence to this Policy Letter.
- 3. <u>DIRECTIVES AFFECTED</u>. These changes will be incorporated into the next revision of reference (a).
- 4. <u>BACKGROUND</u>. Reference (a) requires a day/night pyrotechnic flare for each air crew member on board an Auxiliary aircraft while they are assigned to duty. Due to accountability concerns and references (b)-(e) policy requirements regarding Coast Guard-issued pyrotechnics and commercial pyrotechnic purchases, the Auxiliary Flight Standards Team recommended removing day/night pyrotechnic flares from Auxiliary aircraft and replacing them with a single non-pyrotechnic signaling device for the entire air crew.
- 5. <u>DISCLAIMER</u>. This Policy Letter is not a substitute for applicable legal requirements, nor is it a rule. It is intended to define requirements for Auxiliary personnel and is not intended to, nor does it impose legally binding requirements on any party outside the Coast Guard.

## 6. <u>MAJOR CHANGES</u>. The policy changes below are effective immediately:

a. The Coast Guard requirement for day/night pyrotechnic flares onboard Auxiliary aircraft is rescinded, unless otherwise required by the FARs. Day/night pyrotechnic flares are to be removed from Auxiliary aircraft and replaced with at least one Coast Guard-approved electronic Visual Distress Signaling Device (eVDSD) onboard the aircraft by 01 June 2022 or by the expiration date of the pyrotechnics currently onboard the aircraft if that is prior to 01 June 2022, whichever date comes first.

In accordance with reference (f), eVDSDs that have been accepted as meeting the RTCM 13200.0 standard may be carried to meet regulatory requirements for nighttime distress signals per 33 CFR 175.130.

The eVDSD replaces the nighttime portion of the pyrotechnic. The dye marker or sea rescue device, as required air crewmember survival equipment, replaces the day portion of the pyrotechnic.

Auxiliary aircraft specified in 14 CFR Part 91.501 and conducting overwater operations as specified in 14 CFR Part 91.509 are still required to carry one day/night pyrotechnic signaling device for each life raft.

b. Reference (a), is updated to read:

**D.4 Survival Equipment.** Air crew members must carry the following survival equipment on their person and tethered to the garment worn. It is not necessary for air crew members to duplicate the equipment in the life raft.

- Signaling mirror
- Portable or pocket strobe light
- Dye marker or sea rescue device
- Chemical emergency light
- Whistle
- Survival knife

**D.4.a.** Electronic Visual Distress Signaling Device (eVDSD). Auxiliary aircraft shall carry at least one Coast Guard-approved eVDSD on the aircraft. Air crew members shall store the eVDSD(s) in a position so that it may be removed without air crew members leaving their flight station(s). The air crew member physically closest to the eVDSD position shall ensure it is taken in the event of an aircraft evacuation.

**D.4.b.** Recommended Additional Equipment. Recommended additional equipment includes:

- Insect repellant
- Space blanket
- Waterproof matches

- Sunscreen cream
- Pocket compass
- Air Station Commanding Officers may require additional items necessary for local conditions.

**D.4.c.** In accordance with Financial Resource Management Manual (FRMM), COMDTINST M7100.3 (series), commercial pyrotechnic shall not be purchased using Coast Guard funding.
